## What does StarkMHAR do?

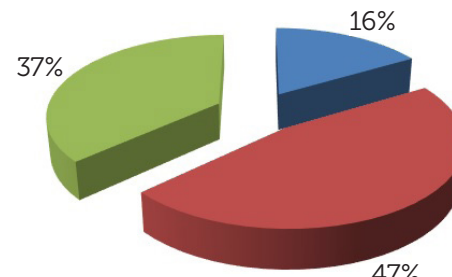

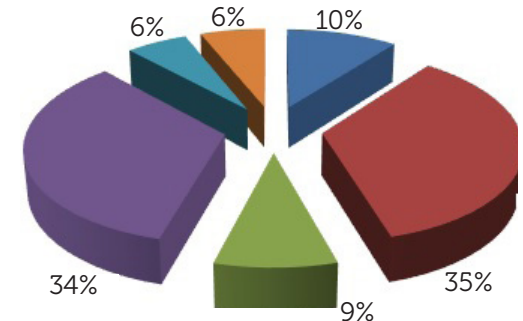
addiction prevention, treatment and recovery support services are available to individuals and families in Stark County.

**Ability to Pay Guidelines** Stark County residents can access behavioral health services regardless of their ability to pay through the Stark County Mental Health & Addiction Recovery (StarkMHAR) Care Network. StarkMHAR funded service providers accept various insurance programs, Medicare and Medicaid. Stark residents that are not covered by one of those options can receive services. Their ability to pay for those services will be determined by their income and could be fully subsidized by StarkMHAR.
